III. Treasurer Report

- A. Cash in account- currently \$4682.45 in account now. Upcoming expenses-taxes, Renewals for state
- B. Fundraising Disbursement to 42nd Street- from Split the Pot \$500
- C. We received a \$45 check from Network for Good from a FB birthday fundraiser.

IV. Old business

- A. Eat and earn Culvers- around \$250

- C. Christmas Split the Pot- was not supposed to be for travel, but it was announced erroneously.

V. New Business

A. Travel bank account- this will help us keep travel money and general funds separate- easier to keep track how much money is earmarked for what. Opening 2/4. First deposit will be the Superbowl pool.

1. General fund:

- a) Yearly organization fees (I am unsure of this exact expense so far for 2023 it is a \$13 fee to the State of Illinois)
- b) Tax Return preparation (don't even have an estimate on this one and has to be completed by a CPA)
- c) Up front fundraising costs
- d) Team Building activities- researched by parents voted on by dancers
- e) Lock-in Costs: We will provide desserts, snacks, and drinks

2. Travel fund:

- a) Team travel in state cover AMAP (parades, state fair, etc.)
- b) Assistance for out of state travel
- B. Eat and Earn S&T- Nicole N. You sell vouchers for about \$2 over the price. So probably sell set up for about \$17.99 (so sell form \$20?)- need to find out if tax is included in the \$17.99. Then you pay for vouchers and pick them up- are good at ALL locations. Nicole said she will make up the form. Target date February



- 15/16 to roll out. Each dancer should be responsible for their own money. One Zelle/ Venmo/ check/ cash payment per dancer.
- C. Fannie May fundraiser- you have to tell them how many boxes/ pieces you want FIRST and front the money. Consensus is it is risky to try and figure it out.
- D. Super Bowl Squares- only 26 more spaces. Nicole M. asked if he will open another board. Dana will ask Mal about it. Sold a square here at the meeting!
- E. Flower Sale- last year we spent \$1000 but we made almost \$1500. We need ribbon and then order the flowers wholesale. We used Global Rose. We can do all payments. Maybe do a ribbon party at dress rehearsal.
- F. Recital Split the Pot- will be at all performances now. We do need adults.
- G. Secretary Opening- Lynn is leaving so there will be a special election for secretary in May. Position will be for one year. General election will be in 2024.
- H. Team event- have something fun that doesn't require a trip. We have about \$1500 that we want to spend on the girls.
