- II. Financial update-
 - o Dues - \$580 (7 families still owe)- one came in at meeting

- III. Explanation of funds distribution
 - Operating Funds retained - \$2,500
 - Remaining Funds distribution ideas:

 - o Question asked: If a girl is not going- how does the money distribution work? The discussion was to divide money equally and hold for those undecided at time of distribution so that if they decide at a later date to attend a distribution can be made at that time.
 - o Another question - can we pinpoint separate things for kids going to do to raise the money instead of the whole team. One parent talked about a bar crawl for the trip.
 - o 11/30 date to commit to trip - Dawn will do an email push. The money raised at that point will be evenly divided among all dancers attending the trip towards their December payment. Motion to approve by Mal and everyone approved.
 - o Possibility in the future for people who do not want to participate in team fundraisers - maybe a buy out rule?
